Minutes of the Council Executive Committee

April 20th, 2021

The meeting was opened at 5:06 PM on Zoom by Kathy Winger, Council President. A quorum was present.

Present: Robert Bernheim, Roger Dahlgren, Jeff Hotchkiss, Jonathan Lang, Steve Odenkirk, Don Riegger, Brett Rustand, and Kathy Winger.

Summary of Action:

- 1. Executive Board minutes for March 16th, 2021 were reviewed. Lang moved, Riegger seconded, approved.
- 2. March Treasurer's report and financials were presented by Council Treasurer Riegger. Significant weakness in support and revenue in March resulted in a monthly deficit of almost \$30,000 and turned the February year-to-date surplus into an \$18,000 deficit on total year-todate revenue of \$133,500. Total support was only \$30,000 led by Friends of Scouting (FOS) at \$7,700. This was \$15,000 behind budget but also reflected an adjustment to a donor's event commitment. Positive signs include increased scouting activity and healthy camp and canoe income of over \$4,300. March expenses, at about \$60,000, remain below budget by about \$15,500. Higher than expected utility and occupancy costs at camps remain a concern. Year-todate expenses of \$151,600 are about \$50,000 under budget. The balance sheet and enterprise value (\$3,686,311) remain in good shape with a healthy cash balance due to receipt of PPP2 funds of \$120,000 while endowment assets reflect strong market value, nearly \$770,000 higher than the 2020 market collapse low. The audit is still in process as additional positive adjustments are valued. Final determination was made for an Employee Tax Retention Credit Refund claim of about \$43,000 but values of donated services and camp improvements are still pending. The Finance Committee began evaluating council resources vis-a-vis post-bankruptcy settlement. They have made a recommendation to reduce leverage by paying off the EIDL loan of \$150,000 and consider settling the interfund line of credit of \$83,000. Additional liquidity will be available to fund expected bankruptcy settlements. The funding call could come as early as May. Lang moved, Rustand seconded, approved.

The Boy Scouts of America may revoke or decline to renew council charters for failure to comply with the Bylaws, Rules and Regulations, or policies of the Boy Scouts of America, or in any instance where it deems such action advisable in the interests of Scouting. Council, Boy Scouts of America, hereby applies for renewal of its charter for the year The Catalina beginning July 1, 2021.

This application has been reviewed and approved by the executive committee or executive board at a duly called meeting on April 20th, ____, 2021 at which meeting a quorum was present, and the council specifically accepted its obligation to cooperate with the Boy Scouts of America and its representatives in promoting the program of the Boy Scouts of America in accordance with the provisions of the Charter, Bylaws, resolutions, policies, and Rules and Regulations of the Boy Scouts of America.

This council agrees with and accepts credit terms of the National Service Center and agrees to the payment of "late payment charges" commensurate with the laws of the state of Texas, from which invoices are issued.

Data submitted, to the best of our knowledge, represents an accurate and complete report of requested information. Finance reports have been prepared in conformity with accounting standards set forth in the Local Council Accounting Manual. This council agrees to submit its financial audit report for fiscal year ending December 31, 2020, a copy of the 990 form, management letter and response to: audits990@scouting.org by July 31, 2021.

Insurance & Risk Management

Local councils are required to have automobile liability insurance coverage of \$1,000,000 combined single limit (CSL) for owned, nonowned, leased or hired vehicles which also provides excess coverage to volunteers and employees engaged in official Scouting activities, on Scouting business, on council business or under your discretion.

If the council does not have owned vehicles, insurance must still be purchased to cover the council for non-owned, hired and leased automobile liability for employees and volunteers.

Councils must submit with the Local Council Charter application, a certificate of insurance showing evidence of the following coverages:

- Automobile liability \$1,000,000 with volunteer coverage endorsement or equivalent language
- Property Insurance
- Workers' Compensation
- D&O excess insurance (if purchased outside BSA offered)
