#### Minutes of the Council Executive Committee

## August 16th, 2022

The meeting was opened at 5:03pm at the Council Service Center by Don Riegger, Council President. A quorum was present.

**Present**: Robert Bernheim, Jeff Hotchkiss, Jerry King, Steve Odenkirk, Don Riegger, and Kathy Winger.

## **Summary of Action:**

- 1. Executive Board minutes for July 9<sup>th</sup>, 2022, were reviewed. Acceptance was moved by Bernheim, seconded by King and approved.
- 2. June & July Treasurer's report and financials were presented by Treasurer King.
  - a. Introduction & Overview for July The Council is beginning to see the challenges of poor revenue streams. Our net income is now at a deficit, and we are subsidizing our low cash position with interfund transfers from endowments. This is not yet a crisis but highlighted with low camp revenues this summer
  - b. Revenue:
    - Overall, our revenue is \$81K behind budget for the year.
    - Friends of Scouting: We are significantly above last year's contributions at this point (\$96K vice \$52K) but we budgeted for \$129K. Added \$2.3K last month.
    - Special Events: We are a bit behind our budget and last year (\$10K) with the Gala as a chance to catch up.
    - Camp: We are up by \$16K on revenues from last year, but lower trading post sales (\$3.5K less). We are well below budget of \$93K at just \$53K revenue from camp fees,
  - c. Expenses:
    - Overall, expenses are consistent with our budget (\$27K below for the year).
    - Employee Compensation: Although up 27% from last year, the staff if still extremely small and we are below budget (below \$45K).
    - Other: Insurance (up \$13K), Occupancy (up \$7K), Rental and Maintenance (up \$11K) and other various increases overall are up 25% over last year (up \$53K overall).

Odenkirk moved, Winger seconded, **approved** July Treasurer's report Odenkirk moved, Winger seconded, **approved** June Treasurer's report

### 3. Resolution Approvals:

- a. After reviewing the Executive Committee approved our **IRS form 990** Moved by Winger, seconded by Bernheim, **approved.**
- b. Approval of an increase in our Council Program fee for 2023.

- d. Membership SE Hotchkiss reported for ASE Shoemake who was at a unit recruitment. Lots of activity with a need for applications to come into the office.
- e. Program President Riegger reported on the plans being made for the summer of 2023
- f. Properties VP Odenkirk reported on the rescheduling of this weekend's Lawton improvement day, and updated the group on the capital projects at camp.
- g. Commissioner service SE Hotchkiss shared the Council Performance Standards report.

- **5. SE Minute:** SE Hotchkiss thanked all for their help in pulling off our weekend summer adventure programs. Lots of positive feedback from that effort.
